CUSTOMS ACT 1967

CUSTOMS DUTIES (EXEMPTION) (AMENDMENT) (NO. 2) ORDER 2015

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs Duties (Exemption) (Amendment) (No. 2) Order 2015**.

(2) This Order comes into operation on 11 June 2015.

**Amendment of Schedule**

2. The Customs Duties (Exemption) Order 2013 [P.U.
