MEMORANDUM OF UNDERSTANDING

Between

UNIVERSITI TUNKU ABDUL RAHMAN

and

YAYASAN KEMANUSIAAN DA SHENG

PURPOSE

The purpose of this MOU is to promote cooperation between Universiti Tunku Abdul Rahman (UTAR) and Yayasan Kemanusiaan Da Sheng (YKDS) in the field of Early Childhood Education.

AREAS OF COOPERATION

Through this MOU, both parties shall agree to respect and uphold the true spirit of collaboration in order to promote the following activities:

- 1. Providing opportunities for UTAR students to carry out teaching practice in Tadika CC Endau (a tadika belongs to YKDS).
- 2. Providing opportunities for the teaching staff of both educational institutions to exchange ideas, experiences and school visits whenever possible.
- 3. UTAR would assist or advise the staff of Tadika CC Endau with teaching related consultation as mutually agreed.
- 4. UTAR will provide preschool teacher training such as workshop to YKDS if required with a reasonable fee applied.
- 5. UTAR and YKDS (including Tadika CC Endau) would enjoy benefits in activities conducted by both parties.
- 6. YKDS would allow UTAR to use its school/company logo for advertising purposes with prior consent given by YKDS.
- 7. YKDS will provide full scholarship for Bachelor of Early Childhood Education (Honours) students to apply. YKDS will take charge to assess, review and approve the scholarship applications.
- 8. Other activities as mutually agreed.

This MOU shall take effect on the date of signing by the authorized officials from Universiti Tunku Abdul Rahman and YKDS. This MOU is valid for TWO (2) years, and automatically renewable for another TWO (2) years, provided that either party may terminate the MOU by giving the other party notice in writing specifying the date of such termination with three-month notice, unless an earlier termination is mutually agreed upon. Revisions or modifications maybe proposed at any time, effective from the date of written document signed by both parties.
