Cleanliness: Blast cleaning to min. Sa 2 $\frac{1}{2}$ (ISO 8501-1:1988) or for maintenance UHPWJ to WJ2 (NACE No.5/SSPC-SP 12). Roughness: using abrasives suitable to achieve minimum grade Fine (ISO 8503-2).

Shopprimed steel

Clean, dry and undamaged approved shopprimer.

Condition during application

The temperature of the substrate should be minimum 5°C and at least 3°C above the dew point of the air, temperature and relative humidity measured in the vicinity of the substrate. Good ventilation is required in confined areas to ensure correct drying.

Application methods

Spray Use airless spray or conventional spray

Brush Recommended for stripe coating and small areas, care must be taken to achieve the

specified dry film thickness.

Storage

Handle with care. Stir well before use. Continuous stirring during application will prevent the heavy zinc pigment from settling.

Packing size

9 litre unit: 8 litres Comp. A (base) in a 10 litre container and 1 litre Comp. B (curing agent) in a 1 litre container.

Packing may vary from country to country according to local requirements.
