4.1. Description of first aid measures.

SUITABLE EXTINGUISHING EQUIPMENT

5.3. Advice for firefighters.

GENERAL INFORMATION In the case of fire, use jets of water to cool the containers to prevent the risk of explosions (product decomposition and excess pressure) and the development of substances potentially hazardous for health. If there are no contraindications, spray powder with water to prevent the formation of dust.

8.2. Exposure controls.
