The process based internal auditing is a management tool that enables the company to take an independent and accurate snapshot to see what an organization looks at a point in time. It checks the 3 C's (compliance, consistency& continual improvement) of an effective ISO 9001 and identifies the room for improvement. It also provides a reporting platform for the evidence of excellent performance in order to provide opportunities for recognition by management and motivation of people

This course will highlights also the new areas of ISO 9001:2015 to be covered under the audit plan. (i.e. context of organization, needs& expectation of interested parties, action plan to address risks and opportunities, knowledge management, control of changes etc).
