SURFACE PREPARATION

General / New Wood

Surfaces must be sound, clean, dry and free from all defective or poorly adhering material, dirt, grease or wax. To have better finish, rubbed down surface in the direction of the grain using suitable abrasive and dust off. It necessary, fill wood grain with appropriate filler and smoothen with abrasive. Allowed paint to dry and lightly dry sand between 1st and 2nd coat

Remove all loose, defective, unstable and existing paint film to bare wood. Rubbed down surface in direction of the grain. If necessary, apply wood grain filler to fill the crack and smoothen with abrasive. Seal the surfaces with SANcora® TIMBER@Guard Polyurethane Wood Stain. Thin down with 10 - 20% mineral spirit.
