### DIRECTIONS FOR USE READ ENTIRE LABEL PRIOR TO USE

It is violation of Malaysia law to use this product in a manner inconsistent with its labeling.

#### How DeTer PRO works?

DoTer PRO for rat is a CONTACT repellent and irritant. In order for it to work it must be placed in areas where rats will come in contact with it and get the product on them. When this is achieved, rat will look for ways to exit from the treated area. DoTer PRO for rats may elicit a stress response that often lower its normal resistance to new things and may enhance operation of current mechanical traps and baits.

When DoTer PRO for rat is applied according to application specifications, rat will not return to treated area for 30 days or longer if product is left intact and undisturbed. Reapplication will be required on and as needed basis in area of high rat pressure or when the product has been disturbed or removed due to foot contact by rats.

#### Where to apply DeTer PRO?

DoTer PRO for rat can be applied indoor and outdoor surfaces which include, but not limited to wood, metal, plastic, tile, and bricks.

- Kitchen
- Food storage areas
- Ceilings
- Attic spaces
- Behind or underneath kitchen equipment
- Exterior perimeter at any potential entry point and along areas where rats might travel
- Under grocery store racks to create a rat "no-Go Zone"
- Inject directly into inaccessible wall voids to drive rats out of hiding
- Areas where you see signs of activity include feces, urine trails and rub marks
- Around the base of trees
- Directly into rat burrows
- Identify food sources and use DoTer PRO to cut off rats from the food source

#### How to apply DeTer PRO effectively?

Before application, clean rat feces from area to be treated. DoTer PRO must be placed in every potential entry point and direct path of rats where contact will occur. Make sure DoTer PRO is applied approximately every 10 ft to ensure rat contact.

For commercial infestation apply DoTer PRO after closing all entry and exit points as stressed rats may become very active once exposed to the product and they attempt to leave the treated area. Make sure you have developed sound rat management strategy using traps and glue boards with non-toxicant food baits. DoTer PRO treatment keeps rats moving around which increase the chance they will leave the treated area and be caught. Use as directed to prevent rats entering to the building.

### PRECAUTIONARY STATEMENT

#### HAZARDS TO HUMANS and DOMESTIC ANIMALS /CAUTION

Harmful if swallowed or absorbed through skin. Causes moderate eye irritation. Avoid contact with skin, eyes or clothing. Make sure DeTer PRO is never placed in areas where humans may accidentally come in contact with the product as the active ingredient causes reddening of the skin and eye irritation. Applicator should wear latex glove and eye protection when applying this product. Any product that contacts the skin should be immediately washed off with soap and water or baby wipes.

#### FIRST AID

##### If In Eyes

Hold eyes open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after first 5 minutes, then continue rinsing eye.

##### If On Skin

Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes.

##### If Swallowed

Have person sip a glass of water if able to swallow. Do not induce vomiting unless told by doctor. Do not give anything to an unconscious person.
