DIRECTIONS FOR USE

Rust or stain Remover

Use concentrate or dilute P-542 one part to two part of water, after applied, brush it then rinse with clean water to clean.

Brightening of non-ferrous metals

Dilute one part of P-542 to 10 part of water apply by soaking, brushing or swabbing.

Treatment on metal surface

Brushing rust from metal surface then use P-542 apply to metal surface, allow to dry before painting. when after treatment, it will leave a layer of phosphate film that improves bonding of paint.

Rubber gloves should be used applying product as it is corrosive. Avoid direct contact with skin as product is acidic. If accidentally in contact especially the eyes, flush with plenty of clean water and seek medical attention if necessary, keep out reach of children and food.
