Everything seemed fine and dandy until the ClearWater dealer showed up for a follow-up call on November 20, 1997.

Just a short note to inform you of an experience we had with one of your Scale Blaster units at one of our McDonalds restaurants.

After the initial installation in late September, 1997, the white calcium build-up in the bathrooms and kitchen due to the excessively hard water that required constant maintenance and repair disappeared. About two months later, one of your representatives stopped by for a follow-up check and the manager then on duty reported that "up until about two weeks ago, the water was great! Then it got bad again." Upon inspection of the installation by your representative, it was found that construction workers doing remodeling in that area had inadvertently disconnected the unit and pulled it out of the wall. It was immediately (and happily) at no charge reinstalled and connected by your representative. The water has been great ever since! We expect the cost savings to be considerable from installing the Scale Blaster unit in terms of soap usage, cleaning supplies and time and effort and especially plumbing and fixture maintenance and repair!

We enclosed some pictures of the initial installation and the way it was found by your representative after accidentally being disconnected. We love the product and recommend the unit for any institution dealing with hard water lime scale problems.
